ORDINANCE TO AMEND ORDINANCE C.S. NO. 11-2569 TO APPROVE AN ADDRESS CHANGE OF THE ST. TAMMANY PARISH REGISTRAR OF VOTERS OFFICE, PERMANENTLY RELOCATING PARISH-WIDE REGISTERED VOTERS FOR EARLY VOTING PURPOSES.

WHEREAS, the Parish Council has received a request from the St. Tammany Registrar of Voters Office to implement a permanent address change; and

WHEREAS, The Registrar of Voters Office has completed their new facility located at 601 North Jefferson Street, Covington, LA adjacent to their previous location at 701 North Columbia Street, Covington, LA. The new location will continue to provide full-time services to all registered voters; while also accommodating parish-wide Early Voting; and

WHEREAS, said approval would be subject to U.S. Justice approval prior to becoming effective.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Ordinance C.S. 11-2569 be amended to change the address of the Registrar of Voters office from 701 North Columbia Street, Covington, LA to 601 North Jefferson Street, Covington, LA, and to be effective upon Justice approval.

BE IT FURTHER ORDAINED that the Registrar of Voters Office is hereby directed to provide notification of said address change via publication in the official journal and the parish government website.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

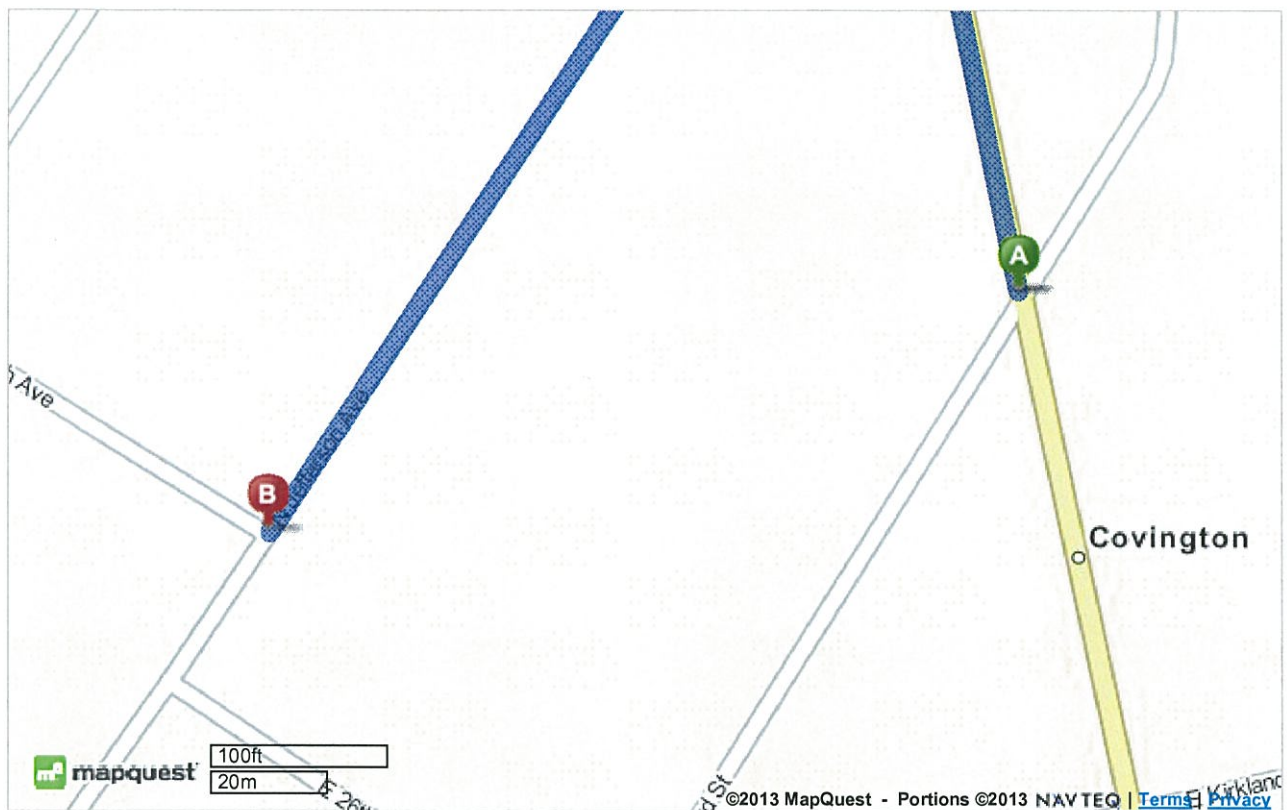
