ORDINANCE TO AMEND ORDINANCE C.S. 11-2569 TO APPROVE A LOCATION CHANGE FOR THREE (3) POLLING LOCATIONS TO INCLUDE PRECINCTS C06, C07, C08.

WHEREAS, La R.S. 18:534 provides for changing of polling locations; and

WHEREAS, the Parish Council has been notified by the St. Tammany Registrar of Voters Office that their physical address is changing from 701 North Columbia Street to 601 North Jefferson Street. This relocation is .029 miles adjacent (across the street) from their current location; and

WHEREAS, due to the modified physical address of the Registrar of Voters Office, the current pollig site for precincts C06, CO7 and C08 has been reevaluated. It has been determined that adequate office space and improved parking allocations would better accomodate voters form these three precinct. It is in the best interest of voters to relocate their polling location from the St. Tammany Justice Center at 701 North Columbia, Covington, LA to across the street at the new Registrar of Voters Office, 601 North Jefferson, Covington, LA; and

WHEREAS, the Registrar of Voters Office is in agreement with this recommnedation and the use of their facility.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it amends Ordinance C.S. 11-2569 to approve a location change for three (3) polling locations to include Precincts C06, C07 and C08.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

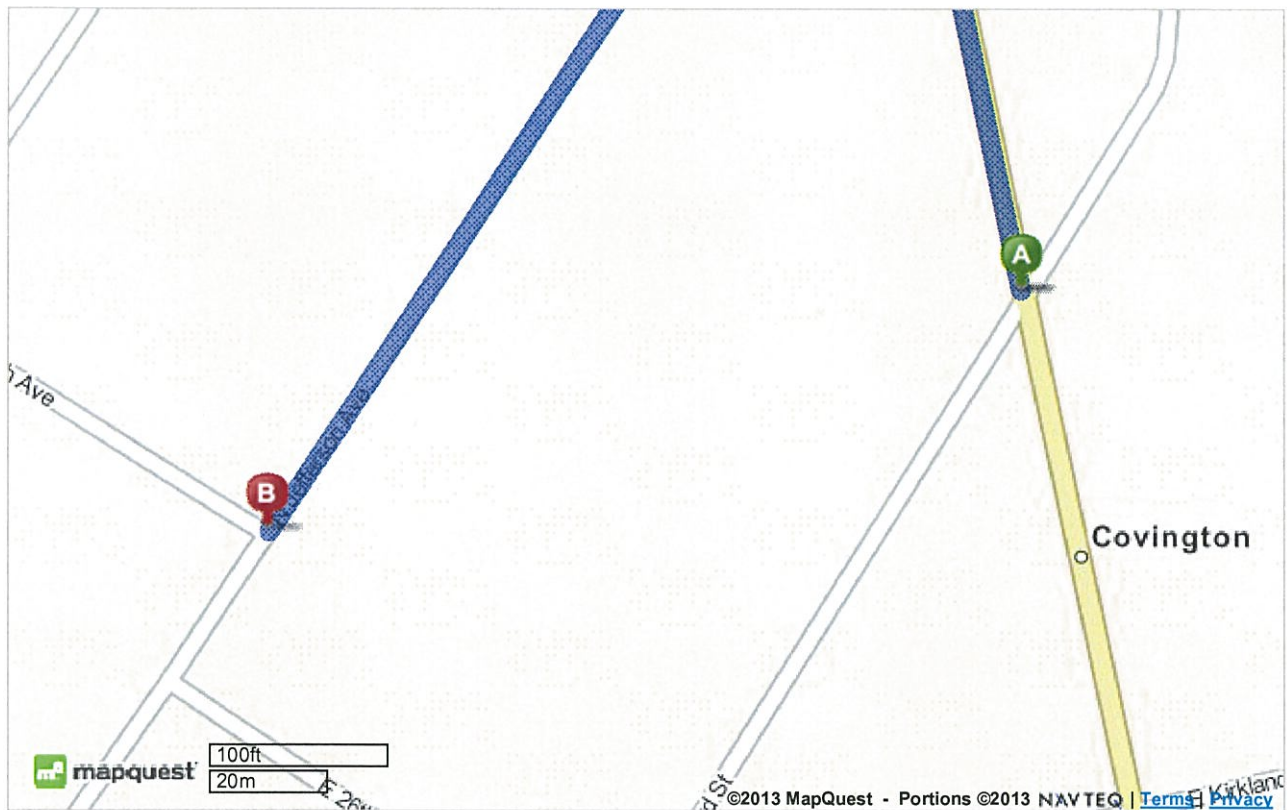
