ORDINANCE ESTABLISHING A NO PARKING ON PAVEMENT
ZONE ON MALTER LANE (4-G-66) WARD 9, DISTRICT 14.
(SMITH)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, due to increased traffic along a narrow roadway.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: A "NO PARKING on Pavement" zone is hereby established on Malter Lane (4-G-66..

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations, in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

6-"NO PARKING on Pavement" (R8-1) signs
1-"NO OUTLET sign
1-"Speed Limit 15" sign

The Department of Engineering recommends the installation of Signage to be installed in District 14.

1. Remove Dead End sign at the beginning of Malter Lane.
2. Install "NO PARKING on Pavement" signs on both sides Malter, 15-20' from the beginning of Malter Lane.
3. Install NO OUTLET sign 25' past Job #2.
4. Install Speed Limit 15 sign on top of existing SC@P sign on Malter Lane.
5. Install "NO PARKING on Pavement" signs on both sides of Malter, between the small dog leg in Malter Lane and mailbox. Install signs 25' south of mailbox.
6. Install "NO PARKING on Pavement" signs on both sides of Malter Lane, just past to large gravel driveways.
