ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO TRANSFER PROPERTY AND IMPROVEMENTS FOR THE LA HWY. 1085 @ LA HWY. 1077 INTERSECTION ROUNDABOUT PROJECT, TO THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) (DISTRICT 1, WARD 1 AND DISTRICT 3, WARD 1).

WHEREAS, St. Tammany Parish Government desires to transfer certain immovable property and improvements (hereinafter referred to as "Property"); and

WHEREAS, there is a need and a public purpose for the transfer of certain immovable property, including rights-of-way and servitudes to LADOTD, for intersection improvements @ LA Hwy. 1085 and LA Hwy. 1077; and

WHEREAS, the Parish of St. Tammany hereby desires to transfer the property, rights-of-way, and/or servitudes and authorizes the Office of the Parish President to do whatever is necessary to transfer said property, rights-of-way, and/or servitudes.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany, to transfer all that certain parcel of ground described in Exhibit "A", attached hereto.

BE IT FURTHER ORDAINED, that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to transfer the property, rights-of-way, and/or servitudes.

BE IT FURTHER ORDAINED, that the Office of the Parish President is authorized and instructed to proceed with the transfer of the property, rights-of-way, and/or servitudes in a timely and orderly matter.

BE IT FURTHER ORDAINED, that the Office of the Parish President is authorized to exercise its discretion in transferring the property, rights-of-way, and/or servitudes, together with all agreements and all transactions necessary to carry out the intent of this Ordinance.

BE IT FURTHER ORDAINED, that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

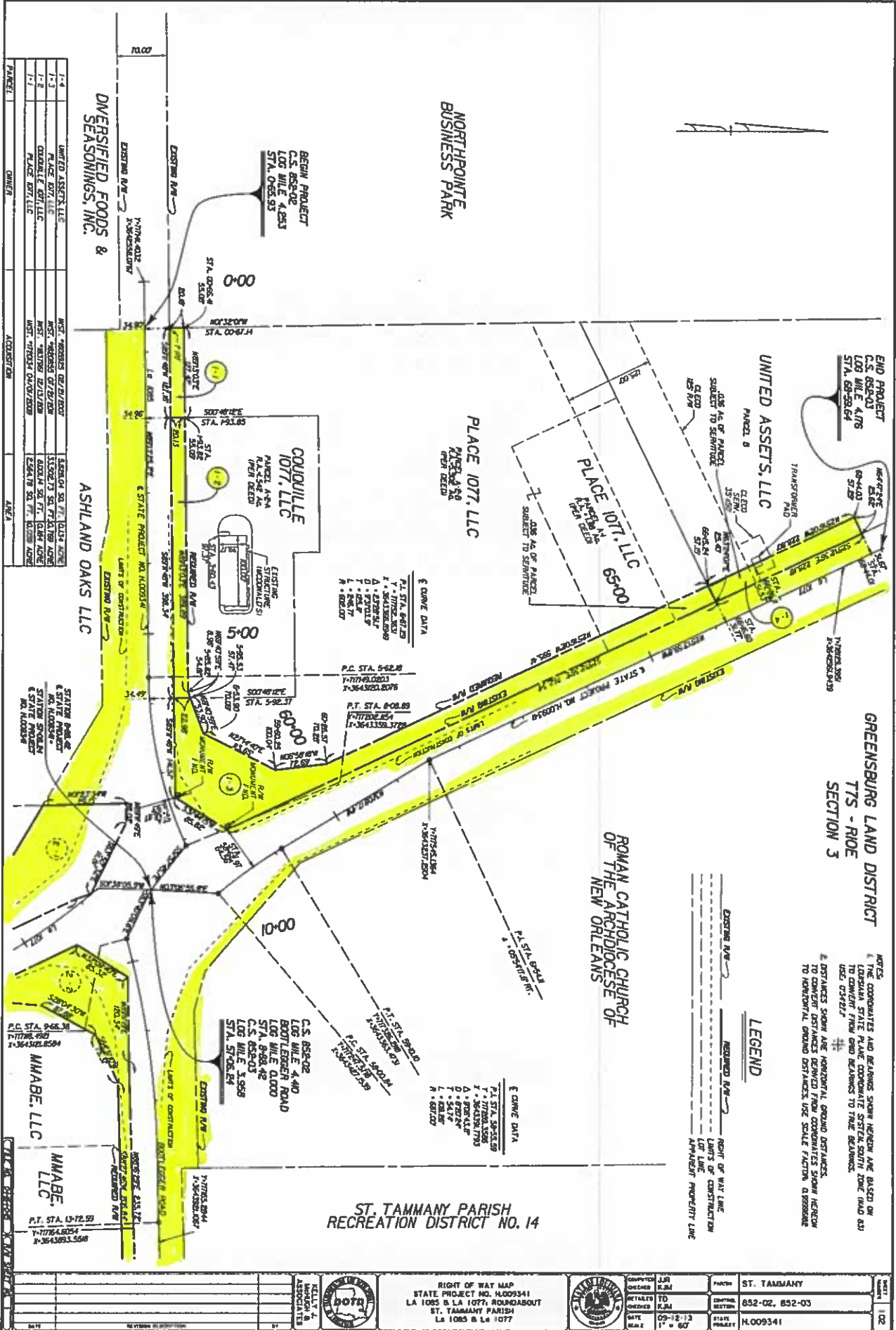
