Ordinance Administrative Comment

ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO A SERVITUDE AGREEMENT WITH WASHINGTON-ST. TAMMANY ELECTRIC COOPERATIVE, INC. FOR ELECTRIC SERVICE TO PARISH'S COMMUNICATIONS TOWER (WARD 6, DISTRICT 11).

The Parish seeks to enter into a servitude agreement with Washington-St. Tammany Electric Cooperative, Inc. for the provision of electrical service to the Parish's communications tower to be constructed on Parish's property near the Animal Services location. No compensation is being exchanged in conjunction with this servitude, as the servitude is needed to provide electricity to the communications tower.
