RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A SUPPLEMENTAL AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR CONSTRUCTION OF A NORTHBOUND RIGHT TURN LANE ON US 190 AT HWY 437 (LEE ROAD) (WARD 3, DISTRICT 3).

WHEREAS, the State of Louisiana, Department of Transportation and Development seeks to extend the right turn lane from the existing north/west bound turn lane on US 190 at its intersection with Highway 437 (Lee Road); and

WHEREAS, the turn lane extension will be funded with a mix of Federal, State and Parish funds; and

WHEREAS, St. Tammany Parish Government desires that the State of Louisiana, Department of Transportation and Development extend the turn lane.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Supplemental Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development for extension of the north/west bound right turn lane from US 190 onto Hwy 437/Lee Road and to take any and all actions necessary to enter into the Supplemental Agreement in support of the turn lane extension.

BE IT FURTHER RESOLVED that all actions previously taken are hereby ratified.
