RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH ST. TAMMANY YOUTH FOOTBALL ORGANIZATION, INC. FOR USE OF HIAWATHA PARK (WARD 9, DISTRICT 14).

WHEREAS, St. Tammany Parish Government owns property consisting of approximately 3.976 +/- acres on Sullivan Road in Slidell, which is commonly known as "Hiawatha Park"; and

WHEREAS, St. Tammany Youth Football Organization, Inc., desires to use Hiawatha Park as a recreational football field for the youth of St. Tammany Parish; and

WHEREAS, in exchange for certain construction and maintenance obligations, Parish desires to allow use of Hiawatha Park as a youth recreational football field.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with St. Tammany Youth Football Organization, Inc. for use of Hiawatha Park, and to take any and all actions necessary to enter into the Cooperative Endeavor Agreement in support of same.
