TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH ST. LUKE THE EVANGELIST ROMAN CATHOLIC CHURCH, SLIDELL, LOUISIANA, INC. FOR AN EMERGENCY WELLNESS PROGRAM.

St. Tammany Parish Government is seeking to enter into a Cooperative Endeavor Agreement commencing in order to provide funding for the Good Samaritan Ministry program, which provides short-term, immediate financial assistance and food bank aid to those in dire circumstances. Funding source is the public health tax, and funding for the 2014 calendar year is \$30,000.00.
