RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A LANDSCAPE MAINTENANCE AGREEMENT WITH THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR THE HIGHWAY 1085/1077 ROUNDABOUT (WARD 1, DISTRICTS 1 AND 3).

WHEREAS, DOTD proposes to landscape the center of the roundabout at the intersection of Highways 1085 and 1077 as part of the roundabout construction project; and

WHEREAS, following installation of the landscaping, Parish will perform the maintenance of the landscaped areas, all as more fully described in the agreement to be confected.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Landscape Maintenance Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development and to take any and all actions necessary to enter into the Landscape Maintenance Agreement in support thereof.
