AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE GENIE DRIVE LATERAL; BOYD ROAD LATERAL; AND SALVATION CHURCH CEMETERY ROAD LATERAL. WARDS 6 & 8, DISTRICTS 11 & 14

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Genie Drive Lateral (#D06GW01013), approximately 375 feet, located northwest off Michelle Drive (R06G011), Ward 6, District 11; and

2. Add Boyd Road Lateral (#D08IW01078), approximately 1,050 feet, located west off Boyd Road (R08I078), Ward 8, District 14; and

3. Add Salvation Church Cemetery Road Lateral (#D08IW01079), approximately 1,910 feet, located west off Salvation Church Cemetery Road to the W-15 canal, Ward 8, District 14.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
