ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF ST. TAMMANY PARISH, LA, TO RECLASSIFY A CERTAIN PARCEL LOCATED ON THE NORTHWEST CORNER OF C. S. OWENS ROAD & LA HIGHWAY 1077 AND WHICH PROPERTY COMPRISES A TOTAL OF 3.91ACRES OF LAND MORE OR LESS, FROM ITS PRESENT A-2 (SUBURBAN DISTRICT) TO AN ED-1 (PRIMARY EDUCATION DISTRICT), (WARD 1, DISTRICT 1). (ZC14-06-045)

Whereas, the Zoning Commission of the Parish of St. Tammany after hearing in accordance with law, Case No. ZC14-06-045, has recommended to the Council of the Parish of St. Tammany, Louisiana, that the zoning classification of the above referenced area be changed from its present A-2 (Suburban District) to an ED-1 (Primary Education District) see Exhibit "A" for complete boundaries; and

Whereas, the St. Tammany Parish Council has held its public hearing in accordance with law; and

Whereas, the St. Tammany Parish Council has found it necessary for the purpose of protecting the public health, safety and general welfare, to designate the above described property as ED-1 (Primary Education District).

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: The zoning classification of the above described property is hereby changed from its present A-2 (Suburban District) to an ED-1 (Primary Education District).

SECTION II: The official zoning map of the Parish of St. Tammany shall be and is hereby amended to incorporate the zoning reclassification specified in Section I hereof.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

ALL THAT CERTAIN PIECE OR PARCEL OF LAND, and its component part, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, prescriptions, appurtenances and advantages thereunto belonging or in anywise appertaining thereto, situated in **Section 14, Township 7 South, Range 10 East, St. Tammany Parish, Louisiana**, consisting of a **portion of Lot 12, Galatas Subdivision**, and being more particularly described as follows, to-wit:

From the southwest corner of Lot No. 12 of Galatas Subdivision, Section 14, Township 7 South, Range 10 East, St. Tammany Parish, Louisiana, run North 64 degrees 00 minutes East a distance of 480.0 feet to an ½ rebar found (bent) located on the northerly right-of-way line of C. S. Owens Road and the POINT OF BEGINNING.

From the POINT OF BEGINNING, run North 14 degrees 46 minutes 27 seconds West 318.44 feet to an ½ inch iron pipe found; thence run North 63 degrees 43 minutes 12 seconds East 149.64 feet to an ½ inch iron pipe found; thence run South 25 degrees 31 minutes 13 seconds East 313.46 feet to an 1 inch iron pipe found on the northerly right-of-way line of C. S. Owens Road; thence run along the northerly right-of-way line of C. S. Owens Road South 64 degrees 05 minutes 59 seconds West 209.1 feet back to the POINT OF BEGINNING.

This tract contains 1.29 acres, all as more fully shown on the survey of Bruce M. Butler, III, Registered Land Surveyor, dated September 19, 2013, revised October 8, 2013.

ALL THAT CERTAIN PIECE OR PARCEL OF LAND, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, prescriptions, appurtenances and advantages thereunto belonging or in anywise appertaining thereto, and being a **part of Lot 12 of the Galatas Subdivision** in Section 14, Township 7 South, Range 10 East, Greensburg District, Louisiana, and being more fully described as follows, to-wit:

Commencing at a point which is reported to be North 519.0 feet, thence South 89 degrees 30 minutes West 1276.5 feet; thence North 23 degrees 30 minutes West 670.4 feet from the corner common to Sections 14, 41 and 44, Township 7 South, Range 10 East, St. Tammany Parish, Louisiana, which point is located at the intersection of the northerly right of way line of C. S. Owens Road and the westerly right of way line of La. Highway 1077 and is designated as Point "A", being the POINT OF BEGINNING.

From the POINT OF BEGINNING run along the northerly right of way line of C. S. Owens Road South 63 degrees 34 minutes 46 seconds West 414.34 feet to a 1 inch iron pipe found; thence run North 25 degrees 31 minutes 13 seconds West 283.69 feet to an ½ inch iron pipe found; thence run North 66 degrees 08 minutes 14 seconds East 418.05 feet to an ½ inch rebar set on the westerly right of way line of La. Highway 1077; thence run along the westerly right of way line of La. Highway 1077 South 24 degrees 44 minutes 37 seconds East 265.17 feet back to the POINT OF BEGINNING.






