ORDINANCE ESTABLISHING A NO PARKING ZONE ON PLACE ST. CLAUDE AND PLACE ST. GERMAIN (WARD 1, DISTRICT 1).

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I: A "NO PARKING" zone is hereby established on Place St. Claude (RO1E034) and Place St. Germain (RO1E034).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations, in accordance with the attached Engineering data.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

The Department of Engineering recommends the installation of Signage to be installed in District 1.

1. Install NO PARKING (Left Arrow) sign at the end of Place St. Claude on the south side, near the Place St. Etienne intersection.
2. Install NO PARKING sign on Place St. Claude, 30' from the walking trail and gate.
3. Install NO PARKING sign in-between Jobs #1 and #2.
4. Install NO PARKING (Right Arrow) sign on Place St. Claude at the Property line of address 806, near pond.
5. Install NO PARKING sign on Place St. Germain, 30' past the existing Stop sign at the Place St. Claude and Place St. Germain intersection.
6. Install NO PARKING sign on Place St. Germain, 30' past the existing Stop sign at the Place St. Claude and Place St. Germain intersection.
7. Install NO PARKING (Right Arrow) sign on Place St. Germain at the Property line of address 501, near pond.
8. Install NO PARKING (Left Arrow) sign on Place St. Germain at the Property line of address 420 (Place St. Michael), near pond.

As per MUTCD, when signs with arrows are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic.
