AN ORDINANCE TO IMPOSE A SIX (6) MONTH MORATORIUM
ON THE OPENING OF NEW STREETS IN ANGELIC ESTATES.
(WARD 3, DISTRICT 5)

WHEREAS, to protect and preserve the health, safety and property interests of residents within Angelic Estates of St. Tammany Parish, a temporary moratorium on the opening of new streets is necessary to allow sufficient time for completion of a punch list of deficiencies affecting the area and remedies therein.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it imposes a six (6) month moratorium on the issuance of permits on the opening of new streets in Angelic Estates in Ward 3, District 5.

BE IT FURTHER ORDAINED that this Ordinance shall be effective immediately upon final adoption and remain in effect through July 7, 2014.

BE IT FURTHER ORDAINED that the moratorium imposed may be vacated, in whole or in part, by Resolution of this governing body pursuant to Chapter 5, Article II, Section 5-0556.00 of the Parish Code of Ordinances.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
