Performance Obligation (\$14,400)

Honorable Council Members:

The Performance Obligation in the amount of \$14,400 expires January 30, 2015 and is scheduled for review by the Parish Council at the December 4, 2014 meeting.

The following punch list items remain:

- 1. Roadside ditches are silted up and need to be regraded to provide positive flow;
- 2. Outfall ditches are silted up and need to be regraded to provide positive flow;
- 3. Swales between lot fill are not functioning and must be constructed in accordance with sheet F-1; dated 9-6-06 prepared by Cooper Engineering, Inc.
- 4. Silt abatement measures are not functioning. Best Management Practices need to be employed to prevent siltation. It will be necessary that your engineer furnish a silt abatement plan for review by our Watershed Coordinator.
- 5. The signs need to be installed along with blue reflectors all in accordance with latest signage specifications;
- 6. As-Built drawings are needed upon completion of the regrading of all ditches, swales and signage:
- 7. The ASPHALT roadway linear cracks need to be cleaned out and approved crack filler material needs to be applied;
- 8. Roadway shoulders need to be constructed in accordance with the approved drawings
- 9. Clean out all cross culverts.

This office has not received notification from the developer's engineer that the punch list items have been accomplished.

Therefore, this obligation must be extended for six (6) months or until the work is satisfactorily accomplished.

Warranty Obligation (\$37,500)

Honorable Council Members:

The Extended Warranty Obligation in the amount of \$37,500 expires January 10, 2015 and is scheduled for review by the Parish Council at the December 4, 2014 meeting.

The developer was notified on October 2, 2014 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least 60 days prior to the expiration of the obligation, that the punch list has been completed.

This office has not received such notification. Therefore, this obligation would normally be called. However, in accordance with Resolution Council Series No. C-1528, passed at the September 28, 2005 Special Parish Council meeting regarding Hurricane Katrina, the Warranty Obligation will be extended for one (1) year or until the work is satisfactorily accomplished.

The following punch list items were submitted to the developer on October 2, 2014 and remain:

- 1. Roadway needs to be broomed for a meaningful inspection to be made;
- 2. Shoulders need to be dressed;
- 3. Catch basins are not protected and allow silt to enter subsurface drainage. Developer's engineer needs to inspect catch basins and subsurface drainage and certify that no silt is present in subsurface drainage.
- 4. Temporary signage has been replaced with permanent signage; need As-Built signage plan and certification from developer's engineer that the signage conforms to current MUTCD standards.
- 5. Blue reflectors need to be replaced;
- 6. As-Built drawing is needed upon completion of detention pond;
- 7. Need Department of Environmental Services approval.
