400-05	Decentralized Arts 2015	State of La. - Office of Cultural Development - funding to function as a Regional Development Agency by developing and implementing a regional arts grants process for St. Tammany and St. Bernard.
420-40	CWEF - Tammany Utilities - Water Meters	State of La. - Div. of Administration - Community Water Enrichment Fund - funding will be used to replace outdated water meters within Tammany Utilities - West service area.
425-01	CSBG - FY 2015	State of La. - La. Workforce Commission - Funds are used for the CAA Staff as well as supportive services for low income families.
425-14	LIHEAP PY 2014	La. Housing Corp (LHC) - Funds to provide energy assistance to low income families.
