



Warranty Obligation (\$37,500)

Honorable Council Members:

The Extended Warranty Obligation in the amount of \$37,500 expires January 5, 2016 and is scheduled for review by the Parish Council at the December 3, 2015 meeting.

The developer was notified on October 2, 2014 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least 60 days prior to the expiration of the obligation, that the punch list has been completed.

This office has not received such notification. Therefore, this obligation must be called.

The following punch list items were submitted to the developer on October 2, 2014 and remain:

- 1. Roadway needs to be broomed for a meaningful inspection to be made;
- 2. Shoulders need to be dressed;
- 3. Catch basins are not protected and allow silt to enter subsurface drainage. Developer's engineer needs to inspect catch basins and subsurface drainage and certify that no silt is present in subsurface drainage.
- 4. Temporary signage has been replaced with permanent signage; need As-Built signage plan and certification from developer's engineer that the signage conforms to current MUTCD standards.
- 5. Blue reflectors need to be replaced;
- 6. As-Built drawing is needed upon completion of detention pond;
- 7. Need Department of Environmental Services approval.

This is a private subdivision and the Parish is not responsible for any maintenance.
