RESOLUTION APPROVING AND AUTHORIZING ST. TAMMANY PARISH THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE VILLAGE OF FOLSOM FOR THE PURPOSE OF ASSISTING THE VILLAGE WITH CERTAIN ROAD IMPROVEMENTS (WARD 2, DISTRICT 3)

WHEREAS, the Village has funds to be used for the purpose of repairs to and construction of roads within the Village of Folsom (the "Project"), and the Village is in need of labor and equipment to implement the road improvements; and

WHEREAS, the St. Tammany Parish Department of Public Works is able to provide its equipment, expertise and labor to assist the Village in the furtherance of the Project. St. Tammany Parish will provide invoices to the Village for use of Parish's labor and equipment which will be reimbursed by the Village; and

WHEREAS, both Parties desire to enter into an agreement for the purpose of setting out each of the Party's duties and obligations in the furtherance of this Project.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement between St. Tammany Parish and the Village of Folsom wherein the Parish will provide labor and equipment to assist the Village in performing certain road improvements and the Village agrees to reimburse the Parish the costs therefore.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

### **Resolution Administrative Comment**

RESOLUTION APPROVING AND AUTHORIZING ST. TAMMANY PARISH THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE VILLAGE OF FOLSOM FOR THE PURPOSE OF ASSISTING THE VILLAGE WITH CERTAIN ROAD IMPROVEMENTS (WARD 2, DISTRICT 3)

The Parish seeks to enter into a Cooperative Endeavor Agreement with the Village of Folsom to assist the Village in road construction and repairs. All costs incurred by Parish for use of Parish's labor and equipment shall be reimbursed by Village. Initial work will consist of construction of an extension of Sabine Street to Greenwood. The agreement will also contemplate future, unknown work to be estimated and agreed upon prior to commencement of such work.
