**Amendment No. 2 - 2014 Operating Budget - February 2014**

**This budget amendment is to :**

**020 - ENVIRONMENTAL SERVICES FUND**

Increase revenue for transfer of funds from escrow as approved per Resolution C-3867 on December 5, 2013 and to increase expenditures associated with Reno Hills Sewer Collection System Construction Project.

**622 - UTILITY OPERATIONS FUND**

Increase revenues and expenditures associated with the Utility Services Agreement between STPG and Hidden Creek, LLC for the construction of a sewer lift station.
