ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES, CHAPTER 7, DRAINAGE AND FLOOD CONTROL, ARTICLE V GRAVITY DRAINAGE DISTRICT NO. 4, SEC. 7-080.00 ESTABLISHED; AMENDED BOUNDARIES, PROVIDING FOR THE AMENDMENT OF THE BOUNDARIES OF GRAVITY DRAINAGE DISTRICT NO. 4 (WARD 4, DISTRICT 5)

WHEREAS, the St. Tammany Parish Council adopted Ordinance C.S. No. 10-2394, dated November 4, 2010, which amended the boundaries of Gravity Drainage District No. 5 to include the area described below; and

WHEREAS, it is the desire of the Parish Council to remove the area described below from Gravity Drainage District No. 4 since it is now included in the boundaries of Gravity Drainage District No. 5.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Code of Ordinances, Chapter 7, Drainage and Flood Control, Article V Gravity Drainage District No. 4, Section 7-080.00 Established; Amended Boundaries, is hereby amended with regard to the boundaries of Gravity Drainage District No. 4, as follows, to-wit:

SECTION 1: By virtue of the authority of St. Tammany Home Rule Charter Section 8-06 and Louisiana Revised Statute 38:1752 and other Constitutional and statutory authority, the boundaries of Gravity Drainage District No. 4 are hereby amended to remove the following described area in its boundaries, to-wit:

A CERTAIN TRACT OF LAND situated in the State of Louisiana, Parish of St. Tammany, in a portion of Sections 15 and 16, Township 7 South, Range 11 East, Greensburg District, Ward 4, and more fully described as follows:

Commencing at the intersection of Highway 59 and Highway 1088; also the point of beginning, thence proceed north along Highway 59 to Interstate 12; thence proceed along I-12 east to Highway 1088; thence proceed southwest on Highway 1088 to Highway 59 intersection; also the point of beginning.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
