ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES, CHAPTER 16, PARKS AND RECREATION, ARTICLE X, RECREATION DISTRICT NO. 9, SEC. 16-102.00 CREATED; BOUNDARIES, PROVIDING FOR THE AMENDMENT OF THE BOUNDARIES OF RECREATION DISTRICT NO. 9 (WARD 9, DISTRICT 13)

WHEREAS, the St. Tammany Parish Council adopted Ordinance C.S. No. 01-0279, dated March 1, 2001, which created Recreation District 15 from a portion of the land included in Recreation District No. 9; and

WHEREAS, it is the desire of the Parish Council to remove the area described below from Recreation District No. 9 since it is now included in the boundaries of Recreation District 15.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Code of Ordinances, Chapter 16, Parks and Recreation, Article X Recreation District No. 9, Section 16-102.00 Created; Boundaries, is hereby amended with regard to the boundaries of Recreation District No. 9, as follows, to-wit:

SECTION 1: By virtue of the authority of St. Tammany Home Rule Charter Section 8-06 and other Constitutional and statutory authority, the boundaries of Recreation District No. 9 are hereby amended to remove the following described area in its boundaries, to-wit:

A CERTAIN TRACT OF LAND situated in the State of Louisiana, Parish of St. Tammany, in a portion of Sections 25 and 26, Township 9 South, Range 13 East, and in a portion of Sections 29, 30, 31, and 32 Township 9 South, Range 14 East, Ward 9, and more fully described as follows:

Commencing at the intersection of U.S. Highway 11 and the northern shore of Lake Pontchartrain, thence follow the northern shore of Lake Pontchartrain westerly to its intersection with the Faciane Canal, thence follow the center of the Faciane Canal easterly to its intersection with the Sourthern Railroad, thence follow the Southern Railroad south to its intersection with Carr Drive; thence follow Carr Drive east to its intersection with U.S. Highway 11, thence follow U.S. Highway 11 south to its intersection with the northern shore of Lake Pontchartrain and the point of beginning.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
