ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 15, ARTICLE II, WATERCRAFT SPEED LIMITS, TO ESTABLISH A **DEAD SLOW, NO WAKE** ZONE ON THE HWY 11 CANAL (WARD 9, DISTRICT 13), A PORTION OF THE MORGAN RIVER (WARD 8, DISTRICT 9) AND A PORTION OF THE BOGUE FALAYA RIVER (WARD 3, DISTRICT 5).

WHEREAS, in the best interest of public safety, health and general welfare, it is deemed necessary to establish a "No Wake" zone for the Hwy 11 Canal, a portion of the Morgan River and a portion of the Bogue Falaya River.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it amends the Parish Code of Ordinances, Chapter 15, Article II, Section 15-006.00, Watercraft Speed Limits, by adding new subsection A (19) relative to the Hwy 11 Canal, subsection A (20) relative to a portion of the Morgan River and subsection A (21) relative to a portion of the Bogue Falaya River as follows, to-wit:

19. The Hwy 11 Canal in its entirety leading to the Schneider Canal pumping station.

20. The Morgan River

a. A portion of the Morgan River commence from southeast corner of the Morgan River where it enters the West Pearl River follow the southern bank of the Morgan River 570 feet to the point of the beginning of the "Dead Slow, No Wake" zone. From the point of the beginning follow the southern bank of the Morgan River 1500 feet to the end point of the "Dead Slow, No Wake" zone.

21. The Bogue Falaya River

a. A portion of the Bogue Falaya River running along Riverside Drive and as depicted on the attached map. REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.


