RESOLUTION TO AUTHORIZE THE FILING OF AN APPLICATION WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR A GRANT UNDER 49, CFR 5311, NON-URBANIZED AREA FORMULA PROGRAM AND/OR 49 CFR 5309, DISCRETIONARY CAPITOL PROGRAM.

WHEREAS, the Secretary of Transportation and Development is authorized to make grants for mass transportation projects; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provisions by it of the local share of project costs; and

WHEREAS, it is required by the Louisiana Department of Transportation and Development in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the Applicant minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment, or consultant and other services:

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that;

1. The Parish President is authorized to execute and file applications on behalf of St. Tammany Parish Government with the Louisiana Department of Transportation and Development, to aid in the financing of operating and/or capital assistance projects pursuant to the Rural Public Transit Program, 49 CFR 5311 and/or Discretionary Capital Program, 49 CFR 5309.

2. The Parish President is authorized to execute and file with such applications an assurance or any other document required by the Louisiana Department of Transportation and Development effectuating the purposes of Title VI of the Civil Rights Act of 1964, as amended.

3. The Parish President is authorized to furnish such additional information as the Louisiana Department of Transportation and Development may require in connection with the application or the project.

4. The Parish President is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.

5. The Parish President is authorized to execute grant contract agreements on behalf of St. Tammany Parish Government with the Louisiana Department of Transportation and Development for aid in the financing of the operating or capital assistance projects.

6. This resolution is applicable for a period of one year unless revoked by the governing body and copy of such revocation shall be furnished to the DOTD.

Administrative Comments

The Resolution authorizes the Parish President (Patricia P. Brister) to execute and file the Rural Public Transit Program (FTA Section 5311) application, assurances, or any other additional information as the Louisiana Department of Transportation and Development (LADOTD) may require in regards to the Rural Public Transit Program. The 5311 application is due February 1, 2015 for the State Fiscal Year July 1, 2015- June 30, 2016.

The goSTAT program is funded by FTA and disbursed through Louisiana Department of Transportation and Development. These funds are used to offset the cost of operating curb to curb transportation to the rural population of St. Tammany Parish. The service operates Monday – Friday 7AM - 5PM. The Parish will be required to provide a 50% match for half of the operations and 20% match for the remaining half of operations, which will be obtained through Partnerships with local Social Service Agencies.
