AN ORDINANCE ESTABLISHING A SPEED LIMIT OF 25 MPH ON A PORTION OF BEVERLY DRIVE (3-D-022). (WARD 3, DISTRICT 3)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, the St. Tammany Parish department of Engineering has evaluated the current speed limit on Beverly Drive (3-D-022) between Lake Ramsey Road and Karrie Lane and have determined that the existing speed limit of 35 MPH should be reduced to 25 MPH.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: in regular session convened that:

SECTION I: A speed limit of 25 MPH is hereby established on Beverly Drive (3-D-022). (Ward 3, District 3)

SECTION II: The St. Tammany Parish Department of Public Works is hereby directed to replace the existing 35 MPH signs with 25 MPH signs and other directional signs as per the St. Tammany Parish Department of Engineering memo attached.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

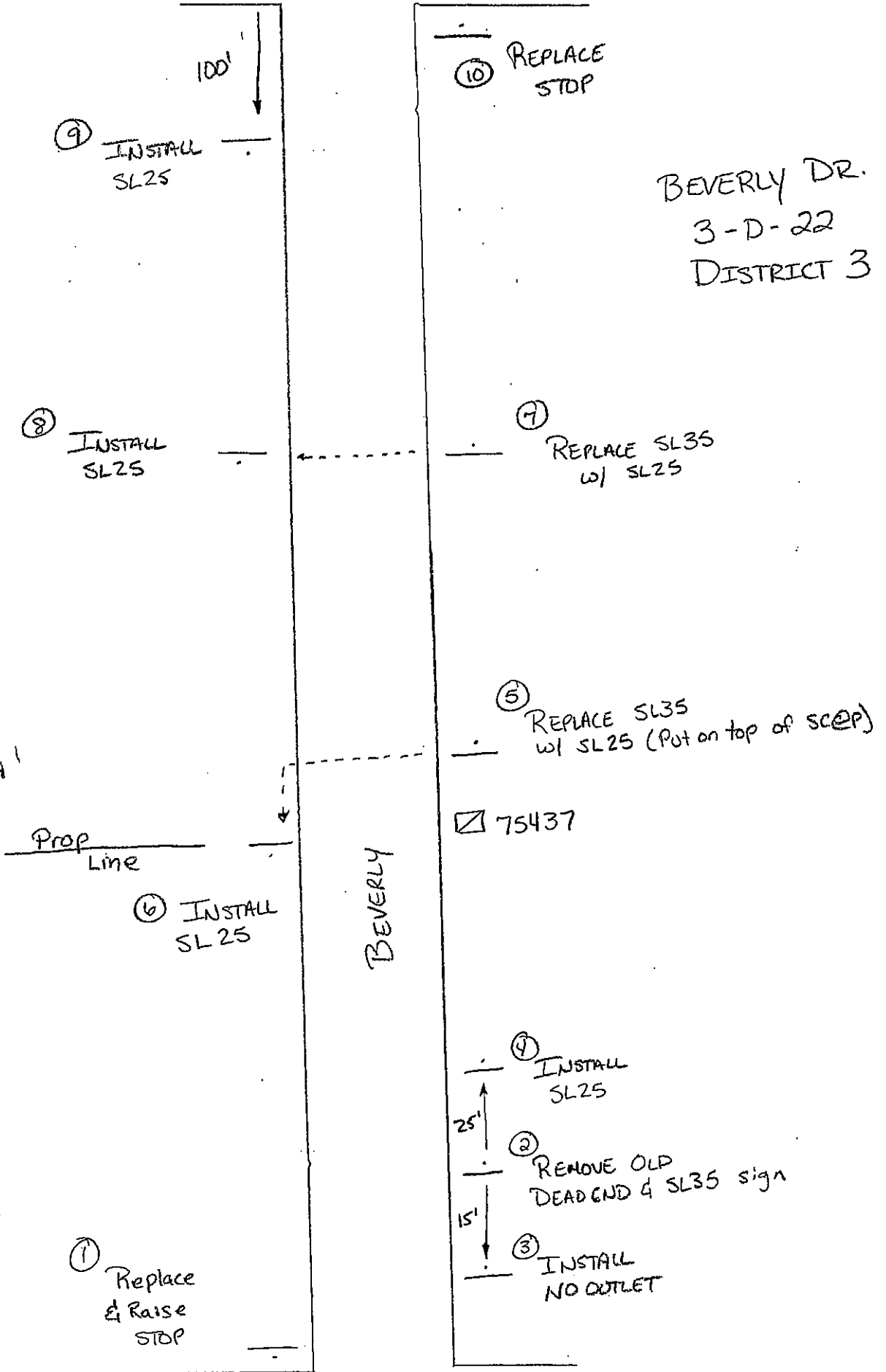
The Department of Engineering recommends the installation of Signage to be installed in District 3.

1. Replace and Raise existing STOP sign on Beverly at the intersection of Beverly and Lake Ramsey.
2. Remove old Dead End sign and Speed Limit 35 sign on Beverly near the intersection of Beverly and Lake Ramsey.
3. Install NO OUTLET sign on Beverly 15' north of the removed dead end sign.
4. Install SPEED LIMIT 25 sign on Beverly 25' south of the removed dead end sign.
5. Replace Speed Limit 35 sign on Beverly near mailbox 75437 with a SPEED LIMIT 25 sign. Put Speed Limit sign on Top of existing SC@P sign.
6. Install SPEED LIMIT 25 sign across from mailbox 75437 on Beverly near Property Line.
7. Replace existing Speed Limit 35 sign on Beverly with a SPEED LIMIT 25 sign.
8. Install SPEED LIMIT 25 sign on Beverly, across from Job #7.
9. Install SPEED LIMIT 25 sign on Beverly, 100' from the Beverly and Karrie intersection.
10. Replace existing STOP sign on Beverly at the Beverly and Karrie intersection.
