ORDINANCE ESTABLISHING THE PLACEMENT OF ALL-WAY
STOP SIGNS AT THE INTERSECTION OF RAPATEL STREET
(R04-E-125) AND CAROLINE STREET (R04-E-034). (WARD 4,
DISTRICT 7)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in traffic at the intersection of Rapatel Street and Caroline Street, in addition to increased traffic concerns while loading and unloading of area school children from the school buses, warranting all-way stop signs at the location of said roadway to assist with traffic control; and

WHEREAS, affected citizens have requested measures be taken to address this traffic control issue on a parish road.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: A all-way stop intersection is established at the intersection of Rapatel Street and Caroline Street. (Ward 4, District 7)

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

We are in receipt of your request for an All-way Stop at the intersections of Rapatel at Caroline.

Due to safety concerns with local school bus stops at this location, the Department of Engineering is not opposed to a council ordinance to place All-Way stop signs at the intersection of Rapatel and Caroline.

Please consult legal counsel before drafting an ordinance or placing the Stop signs, as according to Louisiana Law; we must adhere to the Manual on Uniform Traffic Control Devices (MUTCD). This is outlined in RS 32.235.
