


Ordinance Administrative Comment

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE CERTAIN PARCELS, RIGHTS OF WAYS AND/OR SERVITUDES FOR SLIDELL MANOR SUBDIVISION DRAINAGE IMPROVEMENTS PROJECT (WARD 9, DISTRICT 11).

St. Tammany Parish seeks to acquire certain rights of way and/or servitudes for drainage improvements. Further, the Parish will obtain a 10' Drainage Servitude within Lot 31, Block 13 of Slidell Manor Subdivision, a 10' Drainage Servitude within Lot 32, Block 13 of Slidell Manor Subdivision, and a 20' Drainage Servitude across a 6.23 Acre Tract, for drainage improvements. The Parish intends to pay no more than appraised value or less, plus closing costs and fees.
