TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH NORTHSHORE COMMUNITY FOUNDATION FOR THE PROVISION OF FUNDING TOWARDS ITS NORTHSHORE VISION AND BRANDING PROJECT.

WHEREAS, the Northshore Community Foundation ("NCF") is a non-profit entity whose mission is to unite human and financial resources to enhance the quality of life in the northshore region; and

WHEREAS, NCF is creating a vision and plan for the northshore based on protecting and enhancing the northshore's assets as it grows to achieve its potential with thriving communities within a thriving region; and

WHEREAS, NCF desires to hire a third party to develop a strategic plan for the northshore which will include, among other things, a clearly articulated vision statement and branding for the northshore (the "Vision and Branding Project"); and

WHEREAS, Parish desires to provide funding towards development and implementation of the Vision and Branding Project in consideration of the increased opportunity for economic development and the public benefits to be derived therefrom.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with the Northshore Community Foundation, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the Parish's contribution of funding towards the Northshore Vision and Branding Project.
