RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE OFFICE OF STATE FIRE MARSHALL FOR USE OF SPACE AT THE KOOP DRIVE PARISH ADMINISTRATIVE COMPLEX.

WHEREAS, St. Tammany Parish Government owns and operates the Koop Drive Complex; and

WHEREAS, the State of Louisiana, Department of Public Safety, Office of State Fire Marshall ("Fire Marshall") is in need of office space in St. Tammany Parish; and

WHEREAS, Parish desires to allow Fire Marshall use of office space in Building B in exchange for payment of rent.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Public Safety, Office of State Fire Marshall, for use of office space at Parish's Koop Drive Administrative Complex, and to take any and all actions necessary in support of same.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

### **Resolution Administrative Comment**

RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE OFFICE OF STATE FIRE MARSHALL FOR USE OF SPACE AT THE KOOP DRIVE PARISH ADMINISTRATIVE COMPLEX.

Per a Cooperative Endeavor Agreement, Parish will allow the State Fire Marshall to have use of certain office space (Suite 2D, 850 square feet) at a rental rate equivalent to the rate charged to Southeastern Louisiana University, including CPI escalations.
