RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR RESURFACING OF ALBERU DRIVE AND CHAMALE COVE IN SLIDELL (WARD 8, DISTRICT 12).

WHEREAS, the streets known as Alberu Drive and Chamale Cove consist of one continuous road partially in and out of the corporate limits of the City of Slidell; and

WHEREAS, both Alberu Drive and Chamale Cove are in need of repaving; and

WHEREAS, the Parish and the City of Slidell desire to enter into a Cooperative Endeavor Agreement to split the cost of a contractor to repave both roads; and

WHEREAS, Parish will procure the contractor and Slidell shall provide payment to Parish for a share of the cost for the work.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with the City of Slidell, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the repaving of Alberu Drive and Chamale Cove and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

### **Resolution Administrative Comment**

RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR RESURFACING OF ALBERU DRIVE AND CHAMALE COVE IN SLIDELL (WARD 8, DISTRICT 12).

Alberu Drive and Chamale Cove form one continuous road, which is partially within the corporate limits of the City of Slidell. Combining the repaving work into one project will reduce separate mobilization costs otherwise payable by Parish and City in separate repaving projects. Costs will be shared between the parties.
