RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH LUTHERAN SOCIAL SERVICES DISASTER RESPONSE, INC., FOR HOME REHABILITATION OF KATRINA/RITA DAMAGED PROPERTIES.

WHEREAS, St. Tammany Parish Government, Department of Health and Human Services, has applied for grant funding through the Louisiana Housing Corporation, Inc. for the repair of Katrina/Rita damaged properties of low-to-moderate income citizens of St. Tammany Parish; and

WHEREAS, Parish desires to enter into a Cooperative Endeavor Agreement with Lutheran Social Services Disaster Response, Inc. to perform intake and eligibility of clients, case management services and general compliance with Louisiana Housing Corporation's program requirements.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with Lutheran Social Services Disaster Response, Inc., which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the eligibility determination, case management and compliance with the Louisiana Housing Corporation's program for rehabilitation of Katrina/Rita damaged properties of low-to-moderate income citizens and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

Parish is seeking to enter into a CEA with Lutheran Social Services Disaster Response, Inc., a non-profit corporation, to perform intake and eligibility confirmation services, case management services and program compliance to rehabilitate approximately 13 properties of low-to-moderate income citizens using grant funds awarded or to be awarded by Louisiana Housing Corporation, Inc.
