AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE RUE ACADIAN LATERAL; 4 SYCAMORE PLACE LATERALS; RIVER ROAD LATERAL; AND BONNIE LANE LATERAL. WARDS 3, 4 & 8, DISTRICTS 2, 3, 7 & 13

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Rue Acadian Lateral # D08MW03034 , approximately 1,250 feet, located southwest from Rue Acadian (R08M034) ending at Rue Esplanade., Ward 8, District 13; and
2. Add Sycamore Place Lateral # D04EW01120, approximately 320 feet, located southeast from Sycamore Place ending at a lateral ditch, Ward 4, District 7; and
3. Add Sycamore Place Lateral # D04EW02120, approximately 1,703 feet, located southeast from Sycamore Place (R04E120) ending at a lateral ditch, Ward 4, District 7; and
4. Add Sycamore Place Lateral # D04EW03120, approximately 490 feet, located southeast from Sycamore Place (R04E120) ending at a lateral ditch, Ward 4, District 7; and
5. Add Sycamore Place Lateral # D04EW04120, approximately 1,080 feet, located east then south from Sycamore Place (R04E120) ending at the Lapin Street ditch, Ward 4, District 7; and
6. Add River Road Lateral # D03HW02001, approximately 580 feet, located east from River Road (R03H001) ending at a natural drain, Ward 3, District 2; and
7. Add Bonnie Lane Lateral # D03DW02026, approximately 1,035 feet, located west from Bonnie Lane (R03D026) ending at Lake Ramsey ditch, Ward 3, District 3.

BE IT FURTHER ORDAINED that The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
