## **Ordinance Administrative Comment**

ORDINANCE TO DECLARE LOTS 69 AND 70, MANDEVILLE SUBDIVISION, AS SURPLUS TAX-ADJUDICATED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO HABITAT FOR HUMANITY ST. TAMMANY WEST (WARD 4, DISTRICT 10)

Lots 69 and 70, Mandeville Subdivision (fronting Lambert Street) were adjudicated for non-payment of 1983 taxes. Habitat for Humanity St. Tammany West has identified the property as being desirable to Habitat for acquisition and subsequent construction of affordable housing. Parish Counsel had previously adopted ordinance Council Series No. 12-2757 to establish a program for donating adjudicated properties to Habitat.
