THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to rename Carey Court (R09A047) as Chelsea Court, in conjunction with Act of Correction recorded in the official records of the Clerk of Court and bearing Instrument # 1231027.

BE IT FURTHER ORDAINED that the Department of Public Works is directed to obtain and place the appropriate street signs to so designate the roads as indicated above.
