AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE AN EXTENSION OF RUE DE LA PAIX LATERAL; AN EXTENSION OF WISE ROAD; OLD BAYOU LIBERTY ROAD LATERAL; JESSIE HYATT ROAD LATERAL; DELAUNE ROAD LATERAL; AND DE VAL STREET LATERAL. WARDS 1, 2, 4, 8 & 9, DISTRICTS 3, 5, 6, 11, 12 & 13

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add an approximate 1,705 feet extension to Rue De La Paix Lateral (#D08MW04039) , Ward 8, District 13; and
2. Add an approximate 2,850 feet extension to Wise Road (R01G014), Ward 1, District 3; and
3. Add Old Bayou Liberty Road Lateral # D09HW01035, approximately 240 feet, located south from Old Bayou Liberty Road ending at Bayou Bonfouca, Ward 9, District 12; and
4. Add Jessie Hyatt Road Lateral # D02OW02012, approximately 3,000 feet, located east from Jessie Hyatt Road (R02O012) to Deepwoods Drive (private road), Ward 2, District 6; and
5. Add Delaune Road Lateral # D02HW02008, approximately 300 feet, located east from Delaune Road (R02H008), Ward 2, District 3; and
6. Add De Val Street Lateral #D04DW02021, approximately 1,540 feet, located west from De Val Street (R04D021), Ward 4, District 5.

BE IT FURTHER ORDAINED that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
