AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE CASEY COURT LATERAL AND DOWNING STREET. (WARDS 6 & 9, DISTRICTS 11 & 12)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Casey Court Lateral (#D06GW01025), approximately 300 feet, located southeast off the south end of Casey Court (R06G025), Ward 6, District 11; and
2. Add Downing Street (R09G074), approximately 350 feet, located east off Churchill Road (R09G018), Ward 9, District 12.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
