ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO OFFICIALLY CHANGE THE NAME OF PELICAN BLVD. THAT RUNS NORTHEAST IN SECTIONS 37 AND 43, TOWNSHIP 8 SOUTH, RANGE 12 EAST, ST. TAMMANY PARISH, LOUISIANA, FROM PELICAN BLVD. TO SAFE HAVEN PARKWAY AND FURTHER FOR THE PARISH TO INCORPORATE SAFE HAVEN PARKWAY INTO THE PARISH ROAD AND MAINTENANCE SYSTEM. (WARD 4, DISTRICT 7)

WHEREAS, the Parish of St. Tammany acquired approximately 296 acres of property comprising the former Southeast Louisiana State Hospital Site from the State of Louisiana, which included Pelican Blvd (hereinafter referred to as "property"); and

WHEREAS, the Parish of St. Tammany hereby desires to change the name of Pelican Blvd. to Safe Haven Parkway; as shown on the attached drawing as Exhibit "A"; and

WHEREAS, the Parish of St. Tammany hereby desires to incorporate Safe Haven Parkway into the St. Tammany Parish Selective Road Maintenance System Inventory.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany, to change the name of Pelican Blvd. to Safe Haven Parkway, as shown on the attached drawing as Exhibit "A".

BE IT FURTHER ORDAINED to authorize the incorporation of Safe Haven Parkway into the St. Tammany Parish Selective Road Maintenance System and for the Department of Public Works to provide appropriate maintenance thereto.

BE IT FURTHER ORDAINED that the Department of Public Works is directed to obtain, place and/or remove the appropriate street signs as necessary.

BE IT FURTHER ORDAINED that the Office of the Parish President is authorized to exercise its discretion, with all transactions necessary to carry out the intent of this Ordinance.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

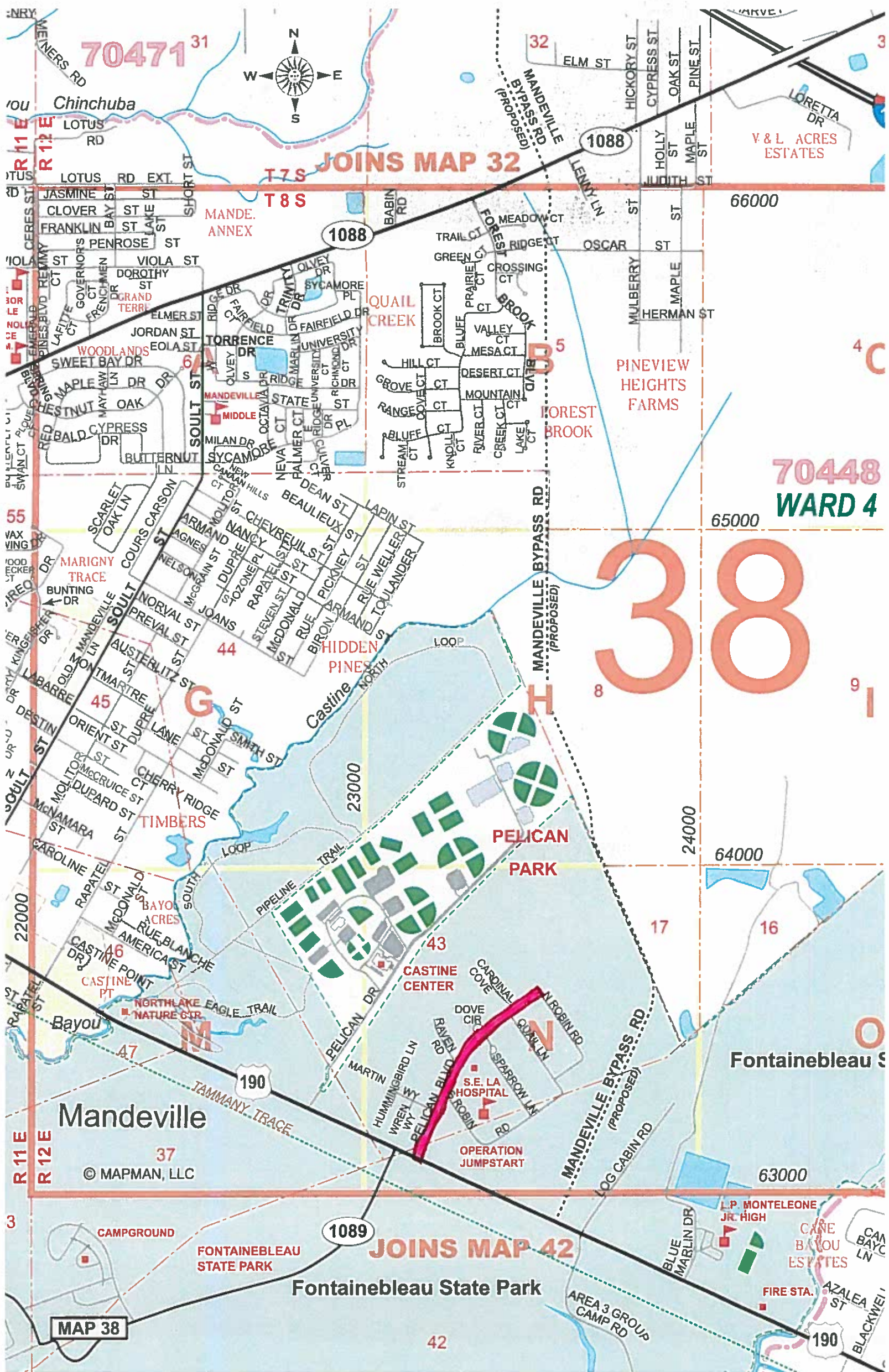
