ORDINANCE ESTABLISHING A NO PARKING ON PAVEMENT ZONE ON NORTH SON MOORE ROAD (8-A-108). (WARD 8, DISTRICT 14)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I: A "No Parking on Pavement" zone is hereby established on N Son Moore Road (8-A-108).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
