ADMINISTRATIVE COMMENT CAPITAL IMPROVEMENTS - MARCH 2013

Fund 316 - Capital Improvements Drainage

Funding Source:

1.83 Millage - Property (Advalorem) Tax

The purpose of this resolution is to realign and update the budget associated with the Parish's share of the LRA Drainage Projects program funded in conjunction with CDBG recovery funds through the State's Office of Community Development (OCD) - Fund 416. The resolution does the following:

1) Provides an additional \$12,000. for completion of the Cypress Bayou Detention Pond project. Additional project management costs due to final acceptance of the pond being delayed while the site is stabilized.

2) Provide \$495,982.75 for the construction costs of the French Branch Channel Improvements.

3) Provide an additional \$13,165.46 for completion of the Labarre St Detention Pond project. Additional project management costs due to changes in scope of the construction project.

4) Remove the funding for Lapin St, Phase 1 \$302,481.05 and Sharp Rd \$ 218667.16 from Fund 316 (Drainage). These projects will be funded 100% with CDBG funds.

There is no net change in the amounts being funded, from either State or local funds, for any of the projects at issue herein. The change in funding source is being necessitated by new deadlines for draw down of CDBG funds recently announced by OCD.
