ORDINANCE ESTABLISHING A NO PARKING ZONE ON SELBOURN STREET (R08-U-016) WARD 9, DISTRICT 12. (BINDER)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, due to increased traffic along a narrow roadway.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: A No Parking Zone is hereby established on Selbourn Street. (R08-U-016).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations, in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

- Re: District 12 Selbourn (8-U-16) 4-"NO PARKING on Pavement" (R8-1) signs 1-"STOP" sign 2-"SPEED LIMIT 25" signs 1-"SELBOURN" Street Name Sign

The Department of Engineering recommends the installation of Signage to be installed in District 12.

As per MUTCD, when <u>signs with arrows</u> are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic.

- 1. Replace SELBOURN Street Name Sign at the intersection of Selbourn and Coast.
- 2. Install a total of 4 NO PARKING ON PAVEMENT signs on the first 150' of Selbourn as indicated on map. The first set should be 20' from the Selbourn and Coast intersection and the second set should be 150' as indicated on map.
- 3. Replace STOP sign at the intersection of Coast and Selbourn.
- 4. Remove old faded no parking sign and install SPEED LIMIT 25 sign.
- 5. Replace existing SPEED LIMIT 25 sign.
