ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE CERTAIN PARCELS, RIGHTS OF WAY AND/OR SERVITUDES FOR THE SHARP ROAD DRAINAGE IMPROVEMENTS PROJECT (WARD 4, DISTRICTS 4 AND 5).

WHEREAS, the St. Tammany Parish Government desires to acquire certain immovable properties (hereinafter referred to as "Properties"); and

WHEREAS, there is a need and public purpose for the acquisitions of certain immovable properties for drainage improvements; and

WHEREAS, the Parish of St. Tammany hereby desires to acquire the Properties, rights of way and/or servitudes and authorizes the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire said Properties, rights of way and/or servitudes.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany, to acquire by purchase, donation or expropriation all those certain parcels of ground described in Exhibit "A" attached hereto.

BE IT FURTHER ORDAINED that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire the Properties, rights of way and/or servitudes.

BE IT FURTHER ORDAINED that the Office of the Parish President is authorized to proceed with the acquisition of the Properties, rights of way and/or servitudes in a timely and orderly manner.

BE IT FURTHER ORDAINED that the Office of the Parish President is authorized to exercise its discretion in acquiring the Properties, rights of way and/or servitudes, together with all agreements and all transactions necessary to carry out the intent of this Ordinance.

BE IT FURTHER ORDAINED that, if purchased, the purchase prices shall not exceed the fair market values of the Properties, as evidenced by an appraisal obtained or supplied to the Parish plus fees and cost.

BE IT FURTHER ORDAINED that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

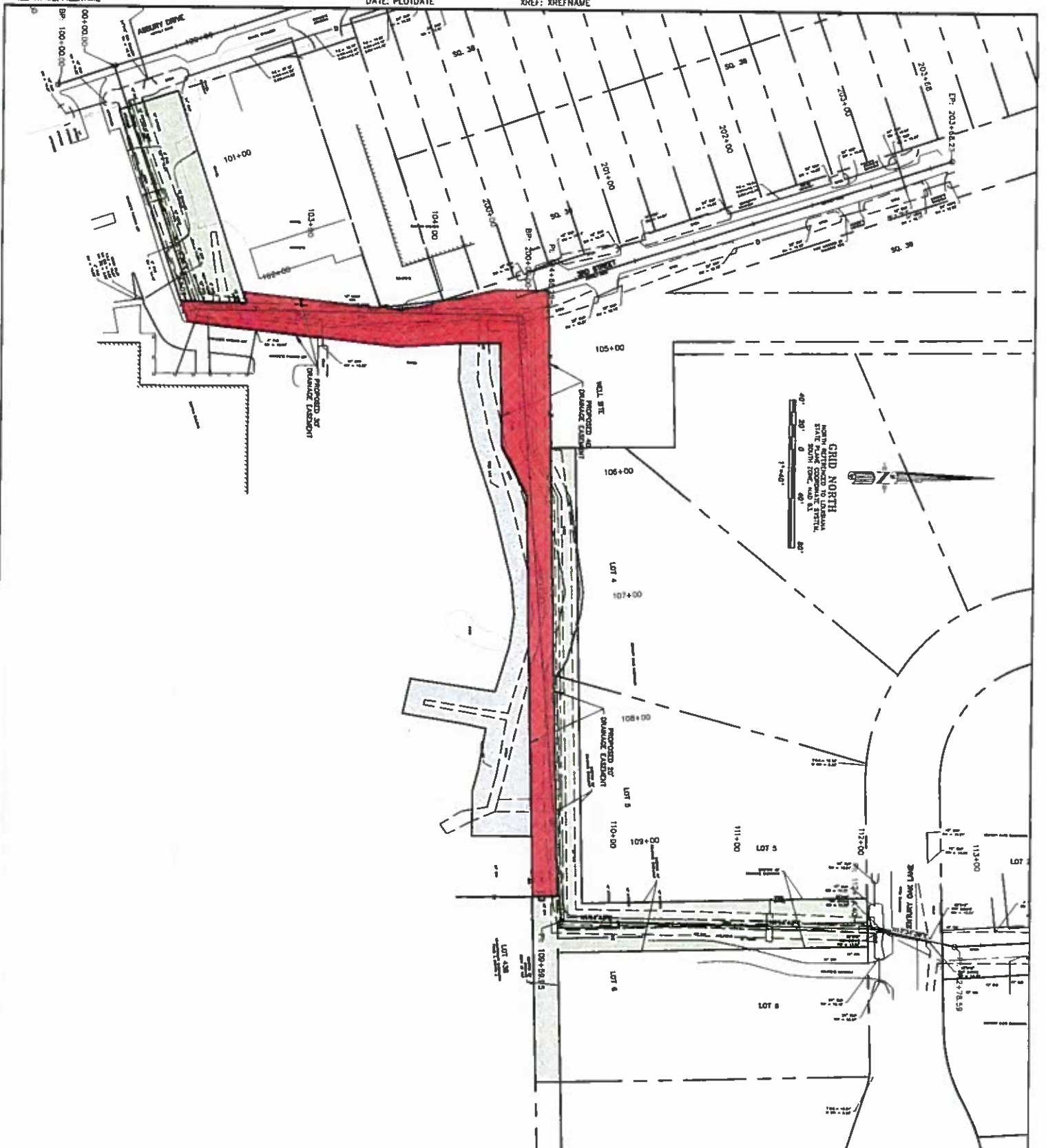

Ordinance Administrative Comment

St. Tammany Parish seeks to acquire certain parcels, rights of way and/or servitudes for the Sharp Road Drainage Improvements Project. The attached survey depicts all required drainage parcels, rights of way and/or servitudes. The Parish intends to pay no more than appraised value or less, plus closing costs and fees for any acquired properties.
