

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXTEND A LEASE ON A PORTION OF THE FOLSOM BARN FOR A COMMUNICATIONS TOWER, AS MORE FULLY DESCRIBED HEREIN AND EXECUTE A LEASE AGREEMENT (WARD 2, DISTRICT 3).

Verizon has requested a cell tower lease at the Public Works' Folsom Barn on Hwy 437. Per public lease law, the lease is to be advertised for bid to the public.
