RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH HUNTWYCK VILLAGE HOMEOWNERS ASSOCIATION, INC. FOR THE USE AND MAINTENANCE OF PARISH-ACQUIRED SRL/HMGP PROPERTIES (WARD 9, DISTRICT 14).

WHEREAS, pursuant to grant funds received by Parish via the Hazard Mitigation Grant Program and/or Severe Repetitive Loss Program, Parish was required to purchase one or more lots located within Huntwyck Village subdivision from approved applicants, namely Lot 578 (517 Drury Lane) (the "Property"); and

WHEREAS, ownership of the Property includes general obligations to maintain such Property in compliance with all applicable Parish ordinances; and

WHEREAS, the Huntwyck Village Homeowners Association ("HOA") desires to use such Property for open space and recreational purposes, and, in exchange for such use, the HOA will agree to maintain the Property; and

WHEREAS, such use and maintenance by the HOA will relieve the Parish from performing maintenance on the Property.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with Huntwyck Village Homeowners Association, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the use and maintenance of one or more HMGP/SRL lots in Huntwyck Village subdivision.
