RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR THE CLEANING OF BRECKENRIDGE CANAL (WARD 8, DISTRICTS 8, 9 AND 13).

WHEREAS, Breckenridge canal is situated inside and outside of the corporate limits of the City of Slidell; and

WHEREAS, Breckenridge canal is in need of work to clear the canal to improve the flow; and

WHEREAS, clearing the canal will improve drainage to citizens in the drainage area comprising Breckenridge Canal; and

WHEREAS, the City of Slidell is willing to undertake and/or contract the needed clearing work; and

WHEREAS, Parish desires to enter into a Cooperative Endeavor Agreement to share the cost of clearing Breckenridge Canal.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with the City of Slidell, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the clearing of Breckenridge Canal and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

Resolution Administrative Comment

RESOLUTION TO ACKNOWLEDGE AUTHORITY PURSUANT TO THE HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR THE CLEANING OF BRECKENRIDGE CANAL (WARD 8, DISTRICTS 8, 9 AND 13).

Breckenridge Canal is partially within the corporate limits of the City of Slidell. Combining the clearing work into one project will reduce separate mobilization costs otherwise payable by Parish and City in separate clearing projects. Costs will be shared between the parties, with Slidell taking the lead on procuring a contractor.
