RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH ST. TAMMANY COUNCIL ON AGING, INC., CITY OF COVINGTON, CITY OF MANDEVILLE, CITY OF SLIDELL, TOWN OF ABITA SPRINGS, AND TOWN OF PEARL RIVER FOR OPERATION AND/OR FUNDING OF GOSTAT.

WHEREAS, St. Tammany is in need of operating and funding partners for its "goSTAT" St. Tammany area public transportation services; and

WHEREAS, St. Tammany desires to enter into a cooperative endeavor agreement with St. Tammany Council on Aging, Inc., City of Covington, City of Mandeville, City of Slidell, Town of Abita Springs, and Town of Pearl River for operation of and funding for goSTAT.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to execute a Cooperative Endeavor Agreement with St. Tammany Council on Aging, Inc., City of Covington, City of Mandeville, City of Slidell, Town of Abita Springs, and Town of Pearl River, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the operation and funding of St. Tammany Parish's goSTAT public transportation service and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all actions previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
