ADMINISTRATIVE COMMENT Grants Resolution May 2014

403-15 CDBG Disaster Recovery - Isaac

Department of Housing & Urban Development - CDBG Disaster Recovery

The *entire* award will be for \$10,914,916. However, the Parish will be receiving the grant funds over the course of two years through a series of grant agreements, one agreement for each project. The projects that will be funded by this grant are as follows:

Tchefuncte Corridor Revitalization	\$5,167,125	
St. Tammany Advanced Campus Infrastructure Project	\$5,317,875	
Family Promise Faith-Based Sheltering Project	\$100,000	
CDBG-DR Program Administration	\$329,916	
TOTAL ALLOCATION	\$10,914,916	

The first allocation of \$329,915 will be for program administration funds. These funds will used to reimburse the Parish for staff/salary expenses for employees who perform administrative tasks in relation to the grant. The funds will also be used to procure a consulting firm to provide overall program management and grant compliance services associated with the following CDBG-DR Isaac projects:

1. Tchefuncte Corridor Revitaliation (Cultural Arts District infrastructure project)

2. St. Tammany Advanced Campus infrastructure project in Lacombe

3. Family Promise Faith-Based Sheltering Project (rehabilitation of a facility to be used

as a day center for the program)
