ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE DUMMYLINE ROAD LATERAL; THORNER ROAD LATERAL, PARISH LINE ROAD; AND ACADIAN DRIVE LATERAL. WARDS 1, 2, 6 AND 8, DISTRICTS 1, 6 AND 11

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Dummyline Road Lateral (#D6GW01006), approximately 550 feet, located north from Dummyline Road (R06G006) and ending at Michelle Drive, Ward 6, District 11; and
2. Add Thorner Road Lateral (#D08AW01004), approximately 1,500 feet, located east from Thorner Road (R08A004), Ward 8, District 11; and
3. Add Parish Line Road, approximately 1,120 feet, located east from Highway 437 ending at turn to the north, Ward 2, District 6; and
4. Add Acadian Drive Lateral (#D01JW01040), approximately 2,000 feet, located northeast from Dummyline Road Lateral, intersecting Acadian Drive and ending at Turf Farms Road Lateral, Ward 1, District 1.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
