ORDINANCE TO CORRECT THE ROAD AND DRAINAGE  
INVENTORY TO INCLUDE, LEAF CIRCLE, FOREST CIRCLE,  
RUSTIC CIRCLE AND GREENERY CIRCLE. WARD 8 DISTRICT

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories; and

WHEREAS, Leaf Circle, Forest Circle, Rustic Circle and Greenery Circle were previously in the St. Tammany Parish Selective Road and Drainage Inventory; and

WHEREAS, Leaf Circle, Rustic Circle and Greenery Circle were removed from the St. Tammany Parish Selective Road and Drainage Inventory by Ordinance 96-2467, dated June 20, 1996: and

WHEREAS, Forest Circle was removed from the St. Tammany Parish Selective Road and Drainage Inventory by Ordinance 97-2701, dated June 19, 1997.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Leaf Circle (R08E145) located off of River Drive (R08E042); and
2. Add Forest Circle (R08E045) located off of Branch Drive (R08E044); and
3. Add Rustic Circle (R08E146) located off of Nature Drive (R08E043); and
4. Greenery Circle (R08E046) located off of Nature Drive (R08E043).

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate street signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
