AN ORDINANCE ESTABLISHING A NO THRU TRUCKS ZONE
ON ALBERT THOMPSON ROAD (2-H-2) WARD 2, DISTRICT 3.
(THOMPSON)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, St. Tammany Parish has experienced an increase in truck traffic through a primarily residential neighborhood; and

WHEREAS, the affected citizens have requested a no thru truck zone to remedy the situation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: A "NO THRU TRUCKS" zone is hereby established on Albert Thompson Road (2-H-2), as indicated on the attached traffic plan by the Department of Engineering. Ward 2, District 3.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

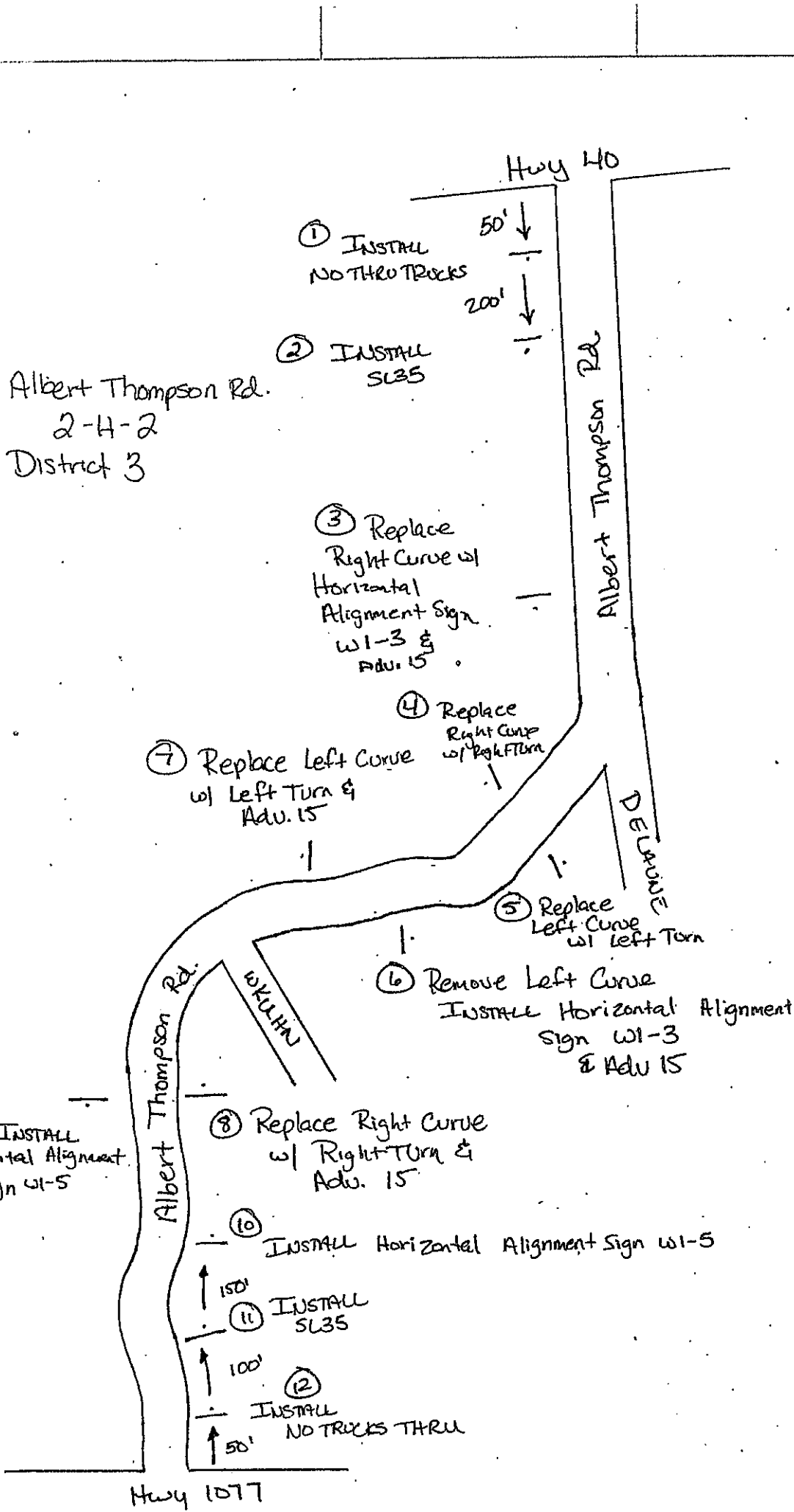

The Department of Engineering recommends the installation of Signage to be installed in District 3.

1. Install NO THRU TRUCKS sign on Albert Thompson Rd. 50' from Hwy 40.
2. Install SPEED LIMIT 35 sign on Albert Thompson Rd. 250' from Hwy 40.
3. Replace Right Curve sign with HORIZONTAL ALIGNMENT sign W1-3 and AVISORY 15 MPH signs.
4. Replace Right Curve sign with RIGHT TURN sign.
5. Replace Left Curve sign with LEFT TURN sign.
6. Replace Left Curve sign with HORIZONTAL ALIGNMENT sign W1-3 and AVISORY 15 MPH signs.
7. Replace Left Curve sign with LEFT TURN sign and ADVISORY 15 MPH.
8. Replace Right Curve sign with RIGHT TURN sign and ADVISORY 15 MPH.
9. Install HORIZONTAL ALIGNMENT sign W1-5 on Albert Thompson Rd. across from Job #8.
10. Install HORIZONTAL ALIGNMENT sign W1-5 on Albert Thompson Rd. 300' from Hwy 1077.
11. Install SPEED LIMIT 35 sign on Albert Thompson Rd. 150' from Hwy 1077.
12. Install NO THRU TRUCKS sign on Albert Thompson Rd. 50' from Hwy 1077.
