RESOLUTION TO ACKNOWLEDGE AUTHORITY, PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE FOOD BANK OF COVINGTON, LA, INC. TO PROVIDE FUNDING FOR OPERATION OF A DENTAL CLINIC.

WHEREAS, The Food Bank of Covington, La, Inc. operates the "Food Bank Dental Clinic", providing comprehensive dental services to qualified low-income individuals; and

WHEREAS, the Parish desires to provide funding resources to support the Food Bank Dental Clinic.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with The Food Bank of Covington, La, Inc. for funding support of its Food Bank Dental Clinic, and to take any and all actions necessary in support of same.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
