RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH GREATER NEW ORLEANS, INC. FOR ECONOMIC DEVELOPMENT INITIATIVES.

WHEREAS, Greater New Orleans, Inc. is an economic development alliance serving southeast Louisiana; and

WHEREAS, St. Tammany Parish desires to enter into a cooperative endeavor agreement with GNO, Inc. for the contribution of funding towards economic development and marketing of St. Tammany Parish, business development, workforce development and non-profit organization support; and

WHEREAS, St. Tammany Parish desires to cooperate with GNO, Inc. in the implementation of the projects developed.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09 is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with Greater New Orleans, Inc. for funding support for economic development initiatives and to take any and all actions necessary in support of same.
