ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO ONE OR MORE SERVITUDE AGREEMENTS WITH VARIOUS UTILITY PROVIDERS FOR THE PROVISION OF UTILITY SERVICES TO THE ST. TAMMANY ADVANCED CAMPUS (WARD 7, DISTRICT 11).

WHEREAS, it is the desire of St. Tammany Parish Government to grant servitudes to one or more utility providers over, under and upon immovable property owned by the Parish for the purpose of providing electrical, gas, communications, video and/or other utility services to the Parish's St. Tammany Advanced Campus site under development; and

WHEREAS, St. Tammany Parish Government has determined that it is in the public interest to enter into various servitude agreements to provide electrical, gas, communications, video and/or other utility services to the St. Tammany Advanced Campus; and

WHEREAS, a plan depicting the locations on which the servitudes are to be granted is attached hereto.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Office of the Parish President is authorized to enter into one or more servitude agreements with utility providers for the St. Tammany Advanced Campus on the property shown on the attached plan for the purposes of providing electrical, gas, communications, video and/or other utility services to the St. Tammany Advanced Campus.

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to execute its discretion in granting utility servitudes on this property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance.

BE IT FURTHER ORDAINED: that all actions previously taken by the Office of the Parish President to grant said servitudes are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.


